- 4. RAIL DESIGNED FOR THE SINGLE USE OF A CERTAIN TYPE OF VEHICLE AND THAT SHOWS A LONGITUDINAL PHYSICAL SEPARATION THROUGH FIXED ELEMENTS, SUCH AS BARRIERS OR CORDS OR BY USING SPECIAL SIGNALING. IT CAN MAINTAIN LEVEL CROSSINGS WITH OTHER ROADS AS WELL AS WITH PEDESTRIANS.
- 5. ACTION OF LOCATING A VEHICLE TEMPORARILY IN AN AREA DESIGNATED FOR THIS PURPOSE.
- 6. EXCEEDING THE NUMBER OF PASSENGERS ESTABLISHED BY THE VEHICLE MANUFACTURER AS THE MAXIMUM CAPACITY.
- 7. PART OF THE STRUCTURE OF THE CIRCULATION ROAD NEXT TO THE ROAD, WHICH SERVES PROTECTION AGAINST THE EFFECTS OF EROSION, EVENTUALLY USED TO STOP VEHICLES IN FORTUITE SITUATIONS OR EMERGENCY CASES AND FOR PEDESTRIAN CIRCULATION.
- 8. PERSONAL AND NON-TRANSFERABLE DOCUMENT, ISSUED BY THE TRANSIT AND TRANSPORTATION AUTHORITY OF PANAMA THAT AUTHORIZES A PERSON TO DRIVE VEHICLES IN THE NATIONAL TERRITORY.
- 9. PAINTED SIGNS ON THE ROAD OR WITH ELEMENTS ADJACENT TO IT TO INDICATE, WARN OR GUIDE TRAFFIC.
- 10. PERSON WHO IS NOT THE DRIVER, AND OCCUPIES A PLACE INSIDE THE VEHICLE.
- 11. ROADWAY AREA DELIMITED BY DEVICES OR MARKS PAINTED ON THE ROAD FOR PEDESTRIANS TO CROSS THE ROAD.
- 12. PERSON WHO TRANSITS ON FOOT, DISABLED PEOPLE OR CHILDREN WHO TRANSIT IN SPECIAL DEVICES DRIVEN BY THEM OR BY ANOTHER PERSON ARE CONSIDERED:
- 13. PRIORITY OR PREFERENCE THAT ONE ROAD OR VEHICLE HAS OVER OTHER ROADS OR OTHER VEHICLES.
- 14. VEHICULAR PREFERENCE PASSAGE RELATED TO THE USE OF THE ROADS THAT INCLUDE THE VEHICLES OF AUTHORIZED OFFICIALS, FIRE DEPARTMENT, NATIONAL POLICE, AMBULANCES AND OTHER EMERGENCY CASES, IN ADDITION TO ANY OTHER STABLISHED BY THE TRANSIT AND TRANSPORTATION AUTHORITY OF PANAMA
- 15. MANEUVER BY WHICH A VEHICLE PASSES ANOTHER VEHICLE WHICH WAS PREVIOUSLY IN THE SAME LANE OF A ROADWAY.
- 16. MOVEMENT OF PEOPLE, ANIMALS OR VEHICLES ON A PUBLIC OR PRIVATE ROAD OPEN TO THE PUBLIC.
- 17. SAFETY REFLECTOR ELEMENT THAT IS PLACED AT AN APPROPRIATE DISTANCE FROM A PARKED VEHICLE IN FORTUITE OR EMERGENCY SITUATIONS IN THE LANES OR ROAD CIRCULATION AREAS, AND WHICH WARN OTHER DRIVERS OF DANGER.
- 18. PERSON WHO CIRCULATES A SECTION OF THE ROADS OR HIGHWAY NETWORK USING ANY KIND OF TRANSPORTATION VEHICLE, MOTORIZED OR NOT
- 19. ZONE OR PUBLIC USE AREA DESIGNATED FOR THE FREE TRANSIT OF VEHICLES, PEDESTRIANS AND / OR ANIMALS, WITHOUT MORE LIMITATIONS THAN THOSE ESTABLISHED BY THIS REGULATION.
- 20. VEHICLE INTENDED FOR TRANSPORTATION OF PROPERLY REGISTERED TOURISTS AND IDENTIFIED AS SUCH, WITH THE RULES AND CHARACTERISTICS THAT ARE REQUIRED FOR THIS ACTIVITY.

- 21. VEHICLES REGISTERED IN OTHER COUNTRIES THAT ENTER THE TERRITORY OF THE REPUBLIC OF PANAMA WILL BE ABLE TO TRANSIT FREELY AS LONG AS THEY HAVE A CIRCULATION PERMIT ISSUED BY THE TRANSIT AND TRANSPORTATION AUTHORITY OF PANAMA FOR A PERIOD OF;
- 22. MOTOR VEHICLES MUST CARRY THE FOLLOWING SAFETY EQUIPMENT WHILE ON THE PUBLIC ROADS:
- 23. IT IS NECESSARY THAT ALL VEHICLES BE IN ADEQUATE SAFETY CONDITIONS, WHETHER FOR PRIVATE USE, FOR STATE SERVICE, FOR PUBLIC PASSENGER TRANSPORTATION OR FOR CARGO. SECURITY CONDITIONS WILL BE REQUIRED ON THE FOLLOWING SYSTEMS:
- 24. PLACE WHERE WILL BE REGISTERED THE OWNERSHIP OF ALL MOTOR VEHICLES AND TOWING UNITS THAT MOVE ON ROADS, STREETS OR PARTICULAR ROADS INTENDED FOR PUBLIC USE THROUGHOUT THE NATIONAL TERRITORY.
- 25. PROHIBITIONS RELATED TO ALL KIND OF VEHICLES;
- 26. EVERY VEHICLE REQUIRES A UNIQUE AND DEFINITIVE PLATE TO TRAVEL ON PUBLIC ROADS, WHICH IS SUPPLIED BY;
- 27. ALL VEHICLES MUST KEEP THE LIGHTS ON FROM
